SALAM in Stuttgart

From 23-24 January, Stuttgart became a hub for innovation in migrant integration, as the SALAM project partners held their latest partnership meeting. The gathering aimed to create a space for the partners to share strategies and best practices for integrating migrants into the labour market, focusing on key challenges such as language barriers, qualification recognition, and access to childcare. Experts from various organisations, including the European Commission, shared examples from their work and contributed to set a solid foundation for sharing valuable policy solutions on getting the best out of migrations in Europe.

Spotlight on Stuttgart 's sustainable migrant integration good practices

During the meeting, **Tobias Diemer**, Director at <u>Volkshochschulverband</u> <u>Baden-Württemberg</u>, emphasised the potential of tapping into a diverse workforce. Representatives from the city of Stuttgart, including **Ayse Ozbacan**, Deputy of Unity Integration Policy, reiterated their commitment to empowering migrants as integral members of society.

Participants visited **Kolping Bildungswerk** to learn about childcare training programs and job creation, then toured the Welcome Centre Stuttgart to see services for newcomers. The second day at the **Ministry of Education Baden-Württemberg** focused on immigrant educational and career guidance, introducing the **Alliance for Lifelong Learning and the LN WBB network**, which supports immigrants through over 200 offices.

The University of Florence Brings SALAM to the classroom

March 2025

The University of Florence has kicked off an important conversation on the topic of migrant integration in the EU with Bachelor students in Sciences of Education during the first term. In her General Pedagogy course, prof. Francesca Torlone, initiated discussions on migrant education, exploring how regional and local services can either support or hinder their integration. This conversation will continue in upcoming lectures, involving students from health and workplace security disciplines. Looking ahead, future discussions will expand to include topics related to prison and gender issues, along with ongoing research in collaboration with several companies.



Interreg Europe Policy Learning Platform cooperates with SALAM

The Policy Learning Platform, part of the Interreg Europe programme, reached out to SALAM to collect and showcase good practices for an upcoming webinar scheduled for April 2025. This webinar will follow up on the <u>December 2024 session</u>, which focused on improving the labour market integration of young people and shared key learnings from various initiatives.

SALAM contributed 7 best practices from the following partners:

- Tuscany Regional Government (Italy)
- Västra Götaland Region (Sweden)
- Baden-Württemberg (Germany)

These practices cover vital areas such as childcare, housing, language, cultural adaptation, and psychological support for migrants, and will be featured in the April webinar. SALAM's involvement with the PLP now includes not only contributing to webinars but also cooperating on events and sharing peer-reviewed papers on integration.







Union of Skills Initiative

In early March 2025, the European Commission introduced the "Union of Skills" initiative, aiming to empower individuals across the EU with the competencies needed for educational and professional success. This initiative seeks to build skills for quality jobs, upskill and reskill an agile workforce, and facilitate the circulation of skills across the EU. By addressing gender imbalances and helping European businesses find the workers they need, it aims to make the EU more competitive and inclusive.

Skills Portability Initiative

As part of the Union of Skills, the Skills Portability Initiative set to launch in 2026, will address the bureaucratic challenges related to cross-border diploma and skill recognition. Looking ahead, initiatives such as the European Degree and European Universities Alliances. The Commission will also work towards a potential European VET diploma for vocational education and training.

2025 EU Budget Allocation

Reflecting its commitment to migration management and integration, the EU's 2025 budget includes a substantial allocation of €2.1 billion specifically for migration-related expenses. This funding supports the union's enduring values of solidarity and human rights, emphasizing the EU's role in assisting migrants and asylum seekers. It reflects the union's dual commitment to managing migratory flows responsibly while fostering inclusive integration, creating a system where member states can better respond to diverse migratory pressures.

Portugal: New platform to promote migrant labour market integration

Lisbon City Council (CML) is developing a pioneering new digital platform to facilitate the integration of migrants into the city's labour market, by matching the skills that migrants have to offer with the needs of local companies. **Read more**

In this publication the Czech government outlines its plan for the implementation of its 2025 integration policy. Finland's Integration Act Reforms

Effective from January 2025, Finland's updated Integration Act mandates municipalities to provide multilingual civic orientation courses. These courses are part of a comprehensive integration program designed to support newcomers' early integration and participation in the workforce. **Read more**

Spain's GECCO Order 2025

Implemented in January 2025, this order facilitates structured and secure employment opportunities for migrants through circular migration programs. It allows temporary modifications of employment contracts and supports both seasonal and stable migration, aiding migrants in acquiring valuable skills and experience. **Read more**
